Vision Zero is a traffic safety initiative that requires designers to consider the needs of all users and provides infrastructure that is designed for all ages, abilities, and forms of transportation. Improving Road User Safety – Pedestrian Safety

This webinar will also discuss: 1) pedestrian issues before and while crossing a street, 2) counter measures that improve pedestrian safety, and 3) information required to select the appropriate counter measure.
