The Senior Heritage Planner is a member of the Cultural Heritage and Urban Design Division within the Development Planning Department. This position is responsible for the supervision of Cultural Heritage staff, preparation and review of reports, strategic planning as it relates to the delivery of cultural heritage services, the development of cultural heritage policies, project management of cultural heritage studies and initiatives, identification of revenue sources and grants for cultural heritage initiatives, and the promotion of public interest in the City's heritage. The Senior Heritage Planner manages the heritage permit process including cultural heritage review of development applications and is responsible for conducting negotiations with developers and owners of heritage properties. This position will prepare cases and may be required to represent the City at the Local Planning Appeals Tribunal (LPAT) hearing as an expert witness on heritage matters. The Senior Heritage Planner is also responsible for overseeing the Heritage Vaughan Committee. This position supports the pressing need for strategic planning, management and preservation of Vaughan's cultural resources.

Qualifications and experience:

- University Degree in Planning, Architectural History, Urban Design, or suitable equivalent.
- Minimum of five (5) years' experience of progressive municipal cultural heritage experience, including a minimum of two (2) years supervisory experience, preferable in a unionized environment.
- Holds a certificate and is a member of the Canadian Association of Heritage Professionals (CAHP).
- Registered as a professional Planner with the Ontario Professional Planning Institute (OPPI)
- Thorough working knowledge of the Ontario Heritage Act, Planning Act, and Canadian Architectural History and proven ability to interpret and apply legislation and policies.
- Demonstrated knowledge of and experience in heritage conservation, architecture, building practices, building typology and design of the built environment.
- Excellent design, report writing, problem-solving and leadership skills.
- Demonstrated ability to effectively lead and manage large complex projects and possesses strong time management skills.
