Applications are now being accepted for the role of Water Treatment Plant Manager in the Public Works Department. This role will direct and supervise the daily operation of the Water Treatment Plant with established environmental, safety and operating standards, policies and emergency response procedures to ensure all regulations and requirements are met for the continuous supply of potable water for the City of Prince Albert and surrounding districts.

### Principle Duties & Responsibilities:

- Monitor the Water Treatment Plant operation, ensuring all safety, operational, and maintenance activities are completed.
- Ensures that all personnel receive safety and process training. Works to identify and provide opportunities for the team to learn new skills and techniques.
- Reviews and evaluates water reports, records, logs, and graphs to confirm adequacy of present and projected water needs. Ensures that uniform monitoring and recordkeeping are performed facility-wide.
- Ensure reports to the Water Security Agency, and any other regulating bodies are completed and submitted accurately.
- Investigate and report on various water treatment issues forwarded through City Council and or public inquiries.
- Supervise, schedule and manage the performance of employees assigned to the Water Treatment Plant.
- Develop and recommend budget requirements during planning process for operating budget.
- Identify and propose short term and long term plans to be considered for future operating or capital budgets.

### Required Qualifications:

- Minimum 2 year post-secondary diploma in an applicable municipal engineering field
- Class 4 Water Treatment Operator certification
- 3 years progressively responsible work experience in a municipal environment.

### Key Knowledge, Technical Skills and Abilities:

- Knowledge of federal and provincial regulatory acts and standards relevant to water treatment and water distribution.
- Knowledge of bylaws, policies and procedures specific to the City of Prince Albert.
- Knowledge of current OH&S standards and regulations.
