Reporting to the Senior Utilities Engineer, in this Exempt position you will be accountable for long range planning and budgeting of municipal water and sewer infrastructure. The Junior Utilities Planning Engineer manages capital projects and ensures completion is on time, within budget, in accordance to municipal standards, and that planned capital and development works are consistent with future utility needs.

Responsibilities
