In addition, the successful candidate will prepare detailed planning reports on policy and development matters, prepare and present planning evidence at Ontario Land Tribunal hearings, as required and assist with enforcement of Zoning By-laws and Site Plan Agreements.

The successful applicant must have knowledge of planning, acquired through a University Degree in Urban Planning, Environmental Studies or related discipline and a minimum of five (5) years of progressive responsible land use planning experience in a municipal environment. The successful applicant will also hold full membership in the Canadian Institute of Planners (CIP) and the Ontario Professional Planners Institute (OPPI) and have their Registered Professional Planners (RPP) designation. This position requires demonstrated attention to detail, strong analytical skills, and knowledge of computer software applications including GIS, AutoCAD, Statistical Database Management and MS Office Applications. In addition, the successful applicant will possess strong management and supervisory skills within a unionized environment, public relations, record keeping, problem solving, report writing, project/time management, analytical, communication skills, both oral and written and shall exhibit excellent interpersonal skills along with maintaining a thorough working knowledge of applicable Provincial Legislation and Policy.
