## Mechanical Maintenance Worker

As a Mechanical Maintenance Worker, you will maintain and repair heating, ventilation and air conditioning (HVAC) systems and related equipment in a number of Water Treatment buildings. Primary duties include:

- Monitor, troubleshoot, diagnose, and repair HVAC systems including boiler systems, motors and pumps.
- Complete preventive maintenance on HVAC equipment, including changing belts, pulleys, filter and pump seals and lubricating motors and pumps.
- Troubleshoot and repair plumbing leaks (for example, hot water heaters) and pneumatic control failures and assist contractors.
- Perform administrative duties such as inputting work requests and entering changes into the Building Automation System and data into the Maintenance Management System.

### Qualifications

- A valid 5th Class Power Engineering certificate (or provincial equivalent) recognized by the Alberta Boilers Safety Association.
- At least 3.5 years of mechanical maintenance experience, including the 6 months required to complete certification.
- A valid Class 5 Driver's License (or provincial equivalent) with no more than 6 demerits OR; a valid Graduated Driver's License (GDL) with no more than 4 demerits, with no current suspensions or charges pending.
- Previous experience using Building Automation System and Maintenance Management System would be considered assets.
- Must be able to demonstrate excellent customer service skills with the ability to communicate well.

**Working Conditions:** Working around conditions such as exposure to CO<sub>2</sub>, confined spaces, heat, noise and dust in boiler rooms and traffic, when driving.

### Pre-employment Requirements

- A security clearance will be conducted.
- Must obtain a City of Calgary [operator's permit](#).
- Successful applicants must provide proof of qualifications.
