## Job Overview

The Township of Langley is currently recruiting for up to two auxiliary temporary full-time **Operations Maintenance Workers** (from approx. August 26, 2024 to December 20, 2024) to join our team of professionals in the Public Works Division, Utilities Operations Department, Utilities Construction group. Reporting to the Utilities Operations Manager, in this unionized position you will perform a variety of semi-skilled and skilled Utilities Construction and maintenance work requiring physical effort and agility. You must have sufficient stamina, strength and coordination to permit the performance of heavy manual outdoor work in all weather conditions.

## Responsibilities

- Utilize a variety of repair processes and equipment such as an M-Scope to locate utilities air compressors and operating a laser level as required
- Operate a dump, flat, panel or service truck of between 5,100 and 24,000 pounds GVW to perform related duties
- Assist in utilities operations, construction and maintenance including the installation and repair of water/sewer services, watermain flushing and water meter installations
- Operate mobile/stationary equipment, guide equipment operators and ensure safe work practices
- Perform related work as required

## Qualifications

- Your education will include completion of Grade 12 or equivalent, supplemented by training courses and considerable related experience in construction and/or maintenance or an equivalent combination of training and experience
- Considerable knowledge of safe work practices and the methods, tools and equipment used
- Ability to use of a variety of tools used in general utilities operations maintenance and construction work
- Sound knowledge of the methods, materials, tools and equipment applicable to the various functional areas of utilities operations maintenance work
- Ability to exercise considerable independent judgment and initiative and operate vehicles safely and efficiently
