The Health and Safety Advisor reports to the Manager of People and Culture and develops and maintains the County's Health and safety program, including hazard identification and control, inspection, incident investigation, audits, training, education, policies, and procedures. The advisor also ensures the County's compliance with applicable federal and provincial legislation.

### **Key Duties**

# **Health & Safety Program**

- Maintains the County's Certificate of Recognition (COR) requirements.
- Provide input into and/or draft safety policies for approval
- Updates Health and Safety Manuals and program documentation, including SDS sheets
- Develops and implements communications for all staff on safety-related issues, updates Safety Bulletin Boards, and contributes to the staff newsletter.
- Acts as a resource for all departments on workplace safety issues.
- Assists in the preparation of reports and presentations.
- Provides input into the Health & Safety budget and manages budgeting expenditures.
- Maintains PPE inventory and orders additional equipment as needed.
- Assists in the development of Contractor Safety Manual
- Collaborates with HR and Payroll on the administration and management of WCB claims, including claims monitoring and providing support for return-to-work programs.

### **Health & Safety Training**

- Plans and implements required safety training programs for all employees.
- Delivers orientation to employees on safety program and guidelines.
- Maintains employee training and safety records (e.g. Training, orientation).
- Participates in the development of Emergency Management training.
- Collaborates with departments to orientate the prime contractors or others hired by the County
  on the County's general safety program guidelines.
