

#### **Job Summary**

The Chief Millwright, Wastewater Services contributes to the effective operation of the RDN's Wastewater Treatment Facilities through the inspection, maintenance, and repair of buildings, equipment and environmental protection infrastructure at these facilities and pump stations. This position supports the Wastewater department by providing leadership and direction to team members in their duties, as required, to meet service expectations, departmental goals, and objectives.

## **Primary Duties and Responsibilities**

- Reviews, adheres to, and supports the adherence to safe work procedures in the workplace and generally promotes a safe work environment.
- Ensure that workers and contractors within their delegated authority have a clear understanding of their role and responsibilities relating to the RDN's health and safety program and Worksafe BC legislation.
- Establish and provide the lead role in safety culture, inclusive of proper identification of training needs, procedures, PPE and legislated responsibilities starting primarily with employee and employer rights, duties and responsibilities. Responsible for establishing and maintaining the highest degree of safety culture through example.
- Performs tasks such as installing, maintaining, servicing, repairing, and aligning all machinery and equipment.
- Supervises and provides direction to Millwrights and co-ordinates work activities with the Superintendent, Wastewater Maintenance to achieve minimal downtime or impact to operations.
- Completes metal fabrication including welding of small parts, brackets, bases, fittings, piping, and miscellaneous components as required to support plant maintenance activities and projects.
- Maintains and controls an inventory of spare parts, equipment, and lubricants. Provides insight and makes recommendations regarding the purchase of related inventory items on an ongoing basis.
- Provides input and assists in the budget process.
- Develops, updates, and implements preventative maintenance standard operating procedures for equipment, and safe operating procedures for staff.
- Develops and implements workflows and processes, makes recommendations to the Superintendent, Wastewater Maintenance.
- Proactively develops and maintains the computerized maintenance system and has oversight of the maintenance files as part of the maintenance strategy. Adheres to a work request / work order system.
- Coordinates with Electricians, Operators, and other tradespeople for the proper isolation of equipment, and how to return it back to service following the completion of work.
- Assists Operations in the interpretation of data from instrumentation and alarms, analyzes, and troubleshoots problems and develops and implements solutions.
- Mentors other Millwrights, Operators and contractors in proper maintenance procedures as it relates to their delegated authority within the Wastewater Treatment Facilities and pump stations.
- Collaborates with the Chief Operator, Wastewater, on all maintenance activities for start-up, shutdowns, routine inspections, and emergency repairs.



# **Job Description**

- Instructs Operators on the technical operation of equipment to optimize equipment life and ensure plant/system safety and efficiency.
- Provides direction and mechanical instruction and guidance to junior level Operators and Operators-In-Training assigned to work on specific projects.
- Performs other related duties as required.
