We are accepting applications for a full-time **Environmental Analyst** to join our team. The Environmental Analyst is responsible for analyzing and evaluating the environmental implications of land use proposals in conjunction with stakeholder and organizational needs and working with consultants from conception to engineering in a project management capacity. Reporting to the Manager of Liquid Waste Planning, the primary responsibilities of this role include:

- Providing environmental analysis and guidance for the Comox Valley Regional District on water, wastewater, rainwater and land use/development projects;
- Leading and coordinating the review of land use development proposals to identify and address operational issues;
- Collaborating with internal Communications to create materials for community outreach, such as, websites, open houses, public meetings, brochures, and displays;

- Organizing and facilitating internal and formal public community meetings, workshops, and open houses as necessary to gain stakeholder support for projects and address operational concerns;
- Working with provincial and federal agencies, First Nations, community groups, and affected stakeholders to ensure their needs and positions are considered in project development and operational initiatives;
- Working with consultants including assigning activities, providing guidance and direction and monitoring the work;
- Preparing written and verbal reports, plans and correspondence, and providing advice on various operational services matters to senior management and elected officials;
- Conducting technical assessments, studies and research regarding a variety of operational matters;
- Providing recommendations for the development or amendment of new and existing bylaws related to the area of liquid waste;
- Responding to inquiries/complaints from the general public regarding operational services issues; explaining and interpreting regional district bylaws, regulations, policies, procedures and permit requirements as well as relevant provincial and federal acts, regulations and orders.

Our ideal candidate is:

- A skilled communicator with the ability to engage multiple stakeholders and resolve conflict when required;
- A strong researcher and facilitator with the ability to create and deliver meaningful presentations;
- Organized, analytical and creative when it comes to problem solving;
- Current in engineering principles, terminology, practices and techniques and comfortable making recommendations on technical matters to senior staff and elected officials;
- Educated in environmental technology or environmental sciences with a diploma OR a four-year degree in a relevant discipline with a minimum of two years related work experience;
- Eligible for registration as an Applied Science Technologist (AScT) with the Applied Science Technologists and Technicians of British Columbia;
- Current in core operational responsibilities and issues related to drinking water treatment and distribution, wastewater collection and treatment and rainwater management;
- Trained in local government or public administration with working knowledge of relevant provincial legislation;
- An advanced user of Microsoft Office with strong skills in Adobe Acrobat and SharePoint and working knowledge of iMap and GIS.

A valid BC Class 5 driver's license is required for this role. Successful candidates will

be required to consent to a Canadian Criminal Record Check.

This is a CUPE Local 556 position with a current wage rate of \$43.27 per hour.
