Reporting directly to the Manager, Engineering Capital, Design and Construction, this role is responsible for the construction management and project delivery of assigned Capital projects for the Town of Caledon. You will perform daily inspections of construction sites to ensure that work is completed according to approved engineering drawings and Town specifications. You will coordinate with consultants, contractors, residents, and Town staff to ensure the terms of project agreements and specifications are being met. As the Project Manager, Capital Inspections, you will perform the following duties, including but not limited to:

- Coordinate, inspect, and report on construction projects to assure compliance with tender drawings, issued construction drawings, and applicable standards.
- Review and provide feedback on construction works, land takings, detailed designs, tender packages, and PUCC applications.
- Perform contract administration and inspection of capital infrastructure, ensuring compliance with agreements, Town standards, and applicable specifications.
- Inspect various construction elements such as storm sewers, roads, retaining walls, and street light installation.
- Develop and distribute project notices for internal and external circulation to stakeholders.
- Investigate, manage, and respond to inquiries from the public, regulatory agencies, staff, and council regarding Town projects.
- Lead construction progress meetings to track project schedules, completed work, and outstanding tasks.
- Monitor and compile project progress reports detailing impacts to schedule, cost, quality, and risk.
- Oversee quality of product/service, cost, and schedule elements of assigned projects.
- Issue compliance orders, deficiency notices, and stop work orders when necessary.
