This position is responsible for entering information into our work order management system.

Conduct regular inspections on vehicles and equipment

Perform service calls including on road calls

Perform repairs within industry established repair times

Follow proper repair procedures, costs/effects/outcomes required to minimize downtime and properly repair vehicles and equipment

Operate and test drive all city vehicles/equipment on and off road as well as shuttle and deliver vehicles when required

Prepare and maintain detailed work-related records including job codes and job notes specific to the repair performed

Must maintain an accurate personal tool inventory
