**The role:** Reporting to the Bylaw Services Manager, and working as part of the bylaw enforcement team, the Bylaw Enforcement Officer performs administrative, inspectional, investigative, and regulatory work related to enforcement of specific bylaws. The incumbent coordinates investigations and assists other departments with their bylaw enforcement issues. The work involves considerable public relations contact and requires the exercise of independent judgment, action, tact and diplomacy within policy, regulation, and bylaw limits. **What we offer:** The rate of pay for this CUPE bargaining unit position is **\$41.58** per hour, based on a **35-hour** work week.   - Must qualify to be appointed as a bylaw enforcement officer as described in the BC Police Act.
  - Conflict resolution training.
  - Customer service training.
  - Occupational First Aid Level 1.
  - Minimum of three (3) years of bylaw enforcement, policing and/or other regulatory enforcement experience.
