- Ability to demonstrate a professional demeanor in personal presentation and conduct;
- Experience with marketing and communications;
- Proficiency in social media platforms;
- Experience with Microsoft Office (word, excel, outlook);
- Level I First Aid, CPR and AED;
- Workplace Hazardous Materials Information System (WHMIS);
- Serving It Right certification; and
- Ability to successfully pass and maintain a satisfactory Police Information Check with Vulnerable Sector (PIC-VS) check.
- Ability to work flexibly as operational required, including weekdays, evenings, and weekends
